## NOTICE

Applications are again invited (due to lack of adequate valid application as per criteria) from eligible candidate from slum /vulnerable population from respective wards for selection of 2 (two) HHW posts as detailed in "Annexure A2" in Ward No. 06 & 28 in Siliguri Municipal Corporation area.

### Eligibility Criteria for HHW:

- Must be female in the age group of 25 - 35 years. In case of SC/ST/OBC (A/B) candidate the upper age limit shall be relaxed 3 yrs (SC) ,5 yrs (ST) .3 yrs (OBC)as per Govt. rules.
- Should be married/divorced/widowed.
- Minimum Madhyamik pass or equivalent exam passed.
- Having motivation /experience of rendering social services.
- Proof of Marriage /widow/divorcee to be provided.
- The list of such finally selected regular and panel candidates shall be displayed ward wise in the Notice Board for information and reporting for selected candidates within stipulated time period for training.
- The list of panel candidates shall remain valid for one year w.e.f. date of notification.
- Induction training of the selected regular candidates for the post HHW shall be conducted at each ULB level for 05 days followed by engagement as HHW. On job training shall be conducted as per ASHA training module under NUHM.
- The regular candidates shall be engaged to the post of HHW on existing consolidated pay of Rs. 3,125/- per month per HHW. The engagement shall be for the period up to 31<sup>st</sup> March, 2019 and shall be continued further on the basis of satisfactory performance and on obtaining approval for extension of the Health Programmes i.e. UPHCS/ CBPHCS/ HHW Scheme.
- The applications with attached photograph are to be submitted along with self-attested photocopy of necessary documents like age proof certificate, mark sheet of Madhyamik or equivalent examination, caste proof, Current Residential Certificate, ID proof (Any) ,proof of Married / Divorced /Widow , Experience Certificate for social services if any .
- Last date of application submission is 20/02/2020, 4-30 PM. The applications are to be submitted in the 'Receive Section' Siliguri Municipal Corporation.
- Applicants are to mention the **Ward Number** for which application is done. One specimen copy of application format is attached as 'Annexure A2'.
