### **:: TERMS & CONDITIONS FOR KIOSK ADVERTISEMENT::**

- 1 The KIOSKS (Hoarding Board) should not be bigger than 30"X 40" and the KIOSKS should be uniform in size.*
- 2. The permission will automatically become invalid on account of display of obscene Hoarding and against the interest of Siliguri Municipal Corporation.*
- 3. The Corporation will not take any responsibility for any loss/defacement/destruction of any KIOSK.*
- 4. The KIOSK Board should be fixed in such a way that public convenience and maintenance work of Electric Lines and installation should not be disturbed.*

5. Only one KIOSK shall be fixed on one Lamp Post. The minimum height of the lower part of the Kiosk shall be 7' (Seven Feet) above road level.
  6. Payment of Lease Money should be made in advance within due date as mentioned in Para 09 fixed by authority concerned and the Lease shall automatically stand cancelled in the event of non-payment of Lease amount within the due date and action will be taken as per law.
  7. Successful tenderer should execute agreement with the Siliguri Municipal Corporation within 15 (Fifteen) days of receiving of offer letter.
  8. Payment should be made to the Cashier, Siliguri Municipal Corporation at a time for 1 (one) year in advance after acceptance of Tender/s for the first year and renewal in the second and third year will be done after enhancing the 1<sup>st</sup> year/2<sup>nd</sup> year rate by 10% & 10% on the original bidding price respectively & no installments except as stated under will be allowed.
  9. Mode of payment of display tax (Payment Schedule):  
For 1<sup>st</sup> year : - Date of payment – Within 7 days of receipt of offer letter.  
For 2<sup>nd</sup> year: - Date of payment - Within 7th of First Month of the bidding year.  
For 3<sup>rd</sup> year: - Date of payment - Within 7th of First Month of the bidding year.
  10. If any person who bids for the tender & withdraws later on the entire Security money will be forfeited along with cancellation of his enlistment & he may be blacklisted also.
  11. Investment of KIOSK Boxes & Light to be made by Agency & also electric bill to be paid by Agency.  
On 5% of the KIOSK Board's Siliguri Municipal Corporation Social Message shall be displayed free of cost during the tenure of Tender.
  12. The minimum base price for this Tender shall be Rs 55,00,000/- per annum (exclusive of all taxes as applicable under the law).
  13. The bidding agency has to submit credential regarding his past experience with any Government Agency during the last two years.
  14. The Corporation reserves the right to cancel the permission at any time by giving one month's notice.
  15. The SMC reserves the right to use the Bifurcation and other adjoining structure with the electric poles for any other commercial purpose/Advertisement to any other agency and for which the bidder to this Tender shall have no objection. However, no other Ad shall be displayed on electric poles.
