XIX) & PAN Card (all in original & two sets of Xerox each) will have to be submitted to the office of the Commissioner, Siliguri Municipal Corporation and failing which no permission for purchasing tender papers will be accorded.

Submission of original certificates is must. Intending contractors may apply quoting name of work together with sl. no. as stated in annexure for obtaining permission for purchasing tender papers well in advance to guard against any difficulties due to possible absence from the headquarter of the concerned officers. Intending tenderers are requested to quote their rates after having been verified the rates of the concerned schedule of rates and site condition well in advance. Percentage rate (above /At par/Less) than the estimate put to tender should be quoted both in figure as well as in words. All corrections in the tender should have initials with date. Any tender paper which does not fulfill any of the above condition or becomes incomplete in any respect shall be liable to be rejected.

The Contractor must obtain the License under the Contract of Labour (Regulation & Abolition) Act 1970 and produce as and when necessary. This may strictly be followed otherwise it will mean violation of contract.

The Commissioner, Siliguri Municipal Corporation, reserves the right to accept or to reject any or all tenders without assigning any reasons thereof to the tenderers.
